1. Introduction

2. Summary of Alumni Feedback

 - Internship and industry exposure.

2.5 Overall Institutional Experience

- Responses showed a wide range—from *Excellent* to *Average*.
- Suggestive comments included:
 - o Improving discipline and academic atmosphere.

Strengthening student support systems.

3. Action Taken by IQAC

- 3.1 Improvement in Teaching Quality
 - Departments were instructed to:
 - o Conduct peer teaching reviews.
 - o Integrate ICT tools into teaching.
 - o Encourage faculty to attend FDPs, workshops, and refresher courses.

3.2 Enhancement of Infrastructure

- IQAC recommended:
 - o Upgradation of classroom facilities (smart boards, projectors).
 - o Procurement of updated laboratory equipment.
 - o Strengthening Wi-Fi and digital library facilities.
- Estate office notified to take up phased maintenance of classrooms and campus facilities.
- 3.3 Strengthening Student Support & Skill Development
 - Placement cell instructed to:
 - o Organize career guidance seminars, soft-skill training, and industry interaction sessions.
 - o Create a structured internship support mechanism.
 - Planning underway to collaborate with external organizations for employability and skill-oriented workshops.

3.4 Administrative Reforms

- Office staff advised to:
 - o Improve response time and efficiency in providing certificates, mark sheets, and student services.

3.5 Alumni Engagement

- Initiatives taken:
 - o Strengthening alumni database.
 - o Planning annual alumni meet.
 - o Creating department-wise alumni networks for academic and placement support.
