# II. Summary of Feedback and Actions Taken

# A. Curriculum, Teaching-Learning & Evaluation

#### **Feedback Received:**

- Curriculum enhances student knowledge.
- Faculty have freedom to use innovative teaching methods.
- Need for more flexibility in assessments and timely exam schedules.

#### **Actions Taken:**

- Departments directed to ensure syllabus completion and submit compliance reports.
- Examination Committee advised to release exam schedules well in advance.

# **B.** Library, ICT & Laboratory Facilities

#### Feedback Received:

- Library and ICT resources generally satisfactory.
- Need for updated books, better internet, more smart classrooms.
- Science departments require upgraded equipment and consistent supply of materials.

#### **Actions Taken:**

- ICT audit initiated; phased upgrade plan for Wi-Fi, projectors, and smart boards prepared.
- Departments asked to submit equipment proposals; Central Procurement Committee formed.
