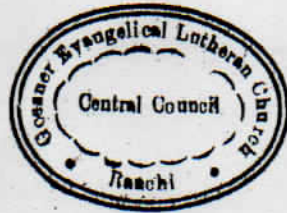

CONSTITUTION OF GOSSNER COLLEGE

(G.E.L.C. REGULATIONS FOR COLLEGE AND UNIVERSITY EDUCATION)

1. Name:- The name of this institution will be "Gossner College".

2. Aims and objects:-

Gossner College will remain under the general direction of the G.E.L.C. The objectives of this institution is to give the Christian Youth a sound liberal education by imparting a sound religious instruction and by maintaining a ~~Christian~~ atmosphere in the College.

The College aims at character building along with physical, mental and spiritual development of students focussing on their social and cultural reorientation.

This institution is open to students of other faiths as well. Their religious feelings and freedom of conscience will be respected in the institution, but public and organised worship other than the Christian will not be carried out in the College and hostel premises. A course on the Science of Ethics and Morals in which man's fundamental duties to God, to self and to his neighbour, are explained will be given to all students of other faiths.

A learning without proper education is a failure to meet the wishes and desires of parents for their children. Therefore, special care will be taken to inspire and motivate students for service with missionary zeal, to train them to gentlemanly manners, and to habits of systematic work with a sense of vocation which will fit them for their duties in life.

3. Minority rights and privileges:-

As Gossner College is established and administered by the Gossner Evangelical Lutheran Church in Chotanagpur and Ranchi, it will enjoy all the rights and privileges of religious minority institutions. The religious minority nature of this institution shall manifest itself as follows:-

Administrative arrangements:-

(a) Gossner College is going to be under the management of a regularly constituted Governing Body by G.E.L.C. consisting of eleven members.

1. The President (Pramukh Adhyaksh) of G.E.L.C. shall be the ex-officio Chairman of the Governing Body;
 - 2-5. Four members of the Governing Body shall be appointed by the G.E.L.C. authorities, one of them will be Vice-Chairman also.
 6. The Principal shall normally be the Secretary also.
 7. One staff representative to be elected in rotation, for one academic year.
 8. One University representative to be appointed by the University.
 - 9-11. Three persons to be nominated to represent the interest of the Adibasis, Chotanagpuris, and others.
- The term of the G.B. shall be 5 (five) years.

(b) Gossner College advisory council:-

For a sound guidance of the Gossner College An Advisory Council shall be constituted by the G.B. There shall be 25 members in the Advisory Council. All the Governing Body members shall become members of the Advisory Council also.

1. The Advisory Council provides opportunity for participation in the thinking and planning for the College. The strength of this body lies in its sound advice to the Governing Body.

2. The advice of the Advisory Council will be honoured by the Governing Body, but it shall not be binding to the latter.

(c) Appointment of teaching staff:-

(1) The appointment of the Principal and Vice-Principal shall be made by the Governing Body from among the members of the G.E.L.C., one of them must be ordained.

(2) Appointment of all other teaching staff shall be made by the College Governing Body.

(3) The names of other members of the teaching staff shall be reported to the proper authorities of Ranchi University and other concerned for information.

(4) The Governing Body of the College shall appoint, dismiss or remove teachers or reduce them in rank or take other disciplinary measures against them and report the same to the Ranchi University and others concerned for information.

(5) In case of dispute the matter be referred to a Tribunal appointment by the G.E.L.C. authorities and the Governing Body.

(6) The academic qualifications and other conditions of the teaching staff shall be in accordance with the laws made by the University.

(d) Policy on Personnel:-

(1) The Principal, Vice-Principal and the Bursar of Gossner College must belong to the G.E.L.C.

(2) As far as possible all the teaching staff must be Chotanagpuris.

Provisions will be made for exchange of teachers from abroad.

(4). College Association:-

- (a) There shall be an allumini association of the old students of the Gossner Colloge.
- (b) There shall be the friends of Gossner Colloge.
- (c) There will be parent teacher day.
- (d) There shall be Library and other social and cultural associations of students in the Gossner Colloge.

(5). Finance of the Colloge:-

- (a) The G.E.L.C. through the Governing Body of the Colloge shall be responsible for the financing of Gossner Colloge. The Principal and the Bursar of the Colloge shall be responsible for the proper administration of the funds.
- (b) The Principal and the Bursar shall present before the G.B. (i) Annual budget (ii) Statement of receipts and expenditures.
- (c) The Colloge Account shall be audited by a Chartered Accountant.

(6). Bye/Laws:-

- (a) Disciplinary regulations of teaching and office staff and students.
- (b) Service conditions of teaching and office staff.
- (c) Leave rules for all employees of the Colloge.

(7). Emergency Regulation:-

In case of any crisis in the Colloge, the G.E.L.C. shall take over the administration of the Colloge.
